Publishing Ethics and Malpractice Statement

The ICCRIP 2025 Organizing Committee is committed to maintaining the highest standards of publication ethics and takes all possible measures against publication malpractice. Authors, reviewers, and editors involved in the conference proceedings are expected to adhere to the ethical behavior outlined below, in line with the principles of the Committee on Publication Ethics (COPE).

A. Responsibilities of Authors

1. **Originality:** Authors must ensure their submissions are original works. All sources and references must be appropriately cited.
2. **Plagiarism:** Manuscripts found to contain plagiarism or self-plagiarism will be rejected or retracted. ICCRIP uses plagiarism detection software for screening.
3. **Multiple Submissions:** Submissions must not be under consideration or published elsewhere.
4. **Authorship:** All listed authors must have significantly contributed to the work. Any changes to authorship must be approved by all authors and communicated to the editors.

5. Disclosure: Authors must disclose any financial or personal conflicts of interest.
6. Corrections: Authors are obliged to promptly inform the editors of any errors discovered post-submission or post-publication and cooperate in issuing corrections or retractions where necessary.

B. Responsibilities of Reviewers

1. Confidentiality: Reviewers must treat the manuscript and related information as confidential.
2. Objectivity: Reviews should be objective and constructive, avoiding personal criticism.
3. Conflict of Interest: Reviewers should recuse themselves if they have any conflict of interest with the manuscript.
4. Timeliness: Reviewers should respond within the agreed review period. If unable to review in time, they should notify the editors promptly.

C. Responsibilities of Editors and Organizing Committee

1. Decision Making: Editors are responsible for deciding which articles are suitable for publication based on academic merit and relevance.
2. Fair Play: Manuscripts shall be evaluated without regard to race, gender, religious belief, ethnic origin, citizenship, or political philosophy of the authors.
3. Confidentiality: Editors and conference staff will not disclose information about submitted manuscripts to anyone other than the corresponding author, reviewers, and other relevant editorial staff.
4. Publication Integrity: The editorial team will take responsive measures to address ethical issues, including retracting or correcting manuscripts when necessary.

D. Allegations of Misconduct

ICCRIP 2025 will take reasonable steps to identify and prevent the publication of papers where research misconduct has occurred. Allegations of misconduct will be investigated following COPE guidelines. Proven cases may result in retraction of papers and notification to the authors' institutions.
